The Hon’ble First Class District Judicial Magistrate, Satna (MP) has passed an Order in favour of the Company directing the Accused i.e. Royal Power Turnkey Implements Pvt. Ltd. and its Managing Director to pay the principal amount of Rs. 7.59 Crores alongwith simple Interest @ 9% p.a., cost and compensation aggregating to Rs. 13.74 Crores to the Company. Further, the Managing Director of Accused viz. Royal Power Turnkey Implements Pvt. Ltd. has been sentenced to rigorous imprisonment of 6 months. However, this Order is appealable and accordingly the financial implications shall be subject to the outcome of the appeal, if filed by the Accused.
